Executive Director's Report, November 19, 2020

Project Updates

Channel Maintenance

Since 2001, the SFCJPA has organized an annual maintenance walk within the Creek channel, during which staff from the SFCJPA, member agencies, and Stanford identify downed trees and other large debris that could obstruct flows and thus pose a threat to public safety during large winter storm events. Items that need attention are tagged and assigned to the appropriate agency for removal or modification. Due to local and State guidelines for gatherings we decided to conduct the Annual Maintenance Walk on San Francisquito Creek differently this year. On September 16 and 23, SFCJCPA staff conducted the walks as usual, and prepared a spreadsheet of items that should be addressed. This spreadsheet was sent to each member agency, assigning work items and instructions to each. As of October 15, all assigned work has been completed, with the exception of a new fallen tree that was reported by a resident after the walks took place. SFCJPA staff will conduct a site visit and assign appropriate action if needed. Kevin Murray led this effort.

Comprehensive Plan

All comments received to date have been integrated into the 2020 Plan.

The 2020 Comprehensive Plan document is now posted on the SFCJPA's website.

At this meeting, we are requesting Board acceptance of the 2020 Plan. The plan will be updated in 2021.

Upstream Project

- Pope-Chaucer Bridge Planning Application. (<u>Project description</u>, the <u>Draft Arborist report</u>, and preliminary design of Pope Chaucer Bridge.):
 - Palo Alto's Architectural Review Board hearing scheduled for December 17 as a study session. A final hearing will be scheduled for January or February 2021.
 - A presentation to East Palo Alto City Council is scheduled for December 1, 2020.
 - A presentation to Menlo Park is not yet scheduled but is expected January 2021.
- Reller Parcel Donation –Thanks to the generous donation by Mr. William Reller, a parcel of land will be donated to the SFCJPA. This land is intended to remain undeveloped and we plan to improve riparian habitat as part of the Upstream Project. Acceptance of Mr. Reller's donation is on the agenda for action as Agenda Item 9.

- Arborist Evaluation We are requesting Board approval for an amendment to the HortSciences/Bartlett contract to respond to City comments on the preliminary arborist evaluation. Consideration of this contract amendment is on the agenda for action as Agenda Item 10
- ESA Scope of Work to accommodate necessary 'Greening' of in-channel project elements status update.
 - At the October meeting the SFCJPA Board approved an amendment to our consultant agreement with ESA to provide permitting support and services for bridge replacement and channel widening upstream of Highway 101. This action included the approval of up to \$60,000 of budget increase to complete the work described in the amendment. Staff has completed negotiations with ESA and agreed to a budget increase not to exceed \$52,000. ESA and staff will proceed with completion of the work items and submit permit applications early in 2021. This is an information item only; no action is needed.
- Discussion of funding needs, funding sources, and timing of funding needs among member agency staff and leadership is in progress.

Upstream detention evaluation

A Request for Proposals was released on October 14. Proposals were received on November 11 and are being reviewed. A review panel with representation from member agencies is assisting staff in the review and selection process. Kevin Murray is leading this effort.

The Stanford Access Agreement has been fully executed. Next steps will be a project kick-off meeting in early 2021 where we begin the inquiry into off-stream detention.

SAFER Bay

FEMA/CalOES BRIC Grant Application. This grant application is proceeding, with multiple public and private collaborators, enabling a local match sufficient to maximize the \$50M grant opportunity. We are on track for a December 3rd grant application submittal. A two-page summary of this application is attached to this report. (see Attachment 1)

The California Department of Water Resources (DWR) approved our invoice for work on the SAFER Bay Phase 1, and we are expecting payment in the next few weeks. We are submitting an amendment request to DWR to update scope and schedule for this grant.

Work will continue to advance design and permitting of the Phase 1 Area in East Palo Alto. Tess Byler is leading SAFER Bay project.

Organization/Administration Updates

- We have initiated a service agreement with an IT professional to evaluate the security and performance of our systems, provide recommendations, and implement any necessary corrective actions.
- We continue to refine and update the website.
- Work continues to complete the FY 2018/2019 Audit.
- Staff has evaluated various banking options, comparing costs, services, ease-ofuse, and customer service. We will be meeting with bank representatives on November 20 to plan this transition, including timing and necessary steps.
- Communication and outreach continue with community members, business leaders, agency staff and leadership, city and county staff and leaders, etc.
 - We are re-establishing a regular check-in and coordination meeting with Stanford University.
- We keep the health and well-being of each other and our community top-of-mind.
 All staff remain cognizant of the need to maintain social distance, practice good hygiene, and wear facemasks.




The project team includes a cross-section of local partners, including federal, state and local government agencies, non-profits and the private sector.

The team has come together to apply for a competitive, pre-disaster mitigation grant from FEMA to cover up to 75% of the project costs.

Working together to protect critical infrastructure

The Menlo Park SAFER (Strategy to Advance Flood protection, Ecosystems, and Recreation) Bay Project is applying for a FEMA grant to protect critical infrastructure amid growing threats of climate change. This project represents wide-ranging local, state, and federal interests and will benefit from letters of public support. If funded, the project will protect infrastructure and communities along more than nine miles of shoreline from projected coastal flooding and sea-level rise. Using nature-based solutions, the levee will allow for habitat restoration of over 550 acres of former salt ponds, and it will increase public recreational access. Construction of the project will also create jobs and engage local communities at every step.



This map shows the project area of the Menlo Park SAFER Bay proposal. The project will design and construct sea level rise protection for reaches 2, 3, 4, and parts of 5.

To ensure Menlo Park's resilience against sea level rise, this project will:

- Support Menlo Park's climate action plans and local electricity grid by protecting PG&E's Ravenswood Substation
- Seek to protect a section of the Dumbarton Bridge western approach and State Route 84, a vital local and regional transportation link for over 80,000 vehicles per day, from flooding.
- Engage local, disadvantaged communities in building climate-smart infrastructure.

- Generate local jobs and economic opportunities as the state prepares for climate adaptation.
- Create needed transition-zone habitat in the SF Estuary, and facilitate salt pond restoration goals.
- Protect local commercial infrastructure including Facebook's Classic Campus.
- Enhance public access and create recreational opportunities in East Menlo Park.

Agenda Item 8: SFCJPA Comprehensive Plan

Background

The SFCJPA <u>2020 Comprehensive Plan</u> is a means to communicate our purpose and projects to diverse audiences. Based on Board review and input, a draft plan was developed and discussed last month.

This plan incorporates comments from the City of Palo Alto, the City of Menlo Park, the Regional Water Quality Control Board, and several community members.

Additional information

By and large, comments have been incorporated into the current document. These comments were helpful in creating a readable, clear and consistent document and are sincerely appreciated. These comments can be summarized as follows:

- Overall, the document is well-written and provides a good overview of the context and purpose of the SFCJPA.
- Add a short explanation of vision, action plan and over-arching goal to help track progress;
 specify SFCJPA mission statement. Make sure summary is consistent with detailed sections.
- For 100-year flood protection with FEMA freeboard, the project should evaluate a suite of floodproofing strategies that can be activated during infrequent flow events that are greater than the 70-year event that the Upstream project protects against.
- Add or update information on stakeholder demographics and provide specific outreach to diverse stakeholders.
- Add more of the regulatory requirements that govern creek actions.
- Add a 70-year flood map
- Concern with ACOE partnership, as the ACOE requires a single purpose flood protection versus the multi-benefit project that the SFCJPA has proposed.

We have updated the document in response to stakeholder comments, with the following exceptions:

- We did not add a 70-year flood map (but will for Upstream permit applications). We did add language that the footprint of the 70-year flood is similar to the 100-year flood, but inundation depths are shallower.
- Rearrange sections as one commenter proposed (if time allows). This may be considered in future editions if section re-organization will more effectively convey the information and intent of the document.
- Where questions of fact were resolved, indicating current content was correct.

This document will be reviewed and <u>updated May-August 2021</u>, tracking progress on projects, and updating relevant changes to organizational or other watershed information. Future updates may include additional maps and graphics, and document organization changes.



Agenda Item 9: Reller Parcel Donation

Background

Mr. Willian T. Reller, resident of Palo Alto, generously offered to donate a portion of his property that is within San Francisquito Creek. To that end, in the SFCJPA completed a Phase 1 Environmental Site Assessment of the property as part of our due diligence in January 2020. No "Recognized Environmental Conditions" were identified in the Phase 1 Report. Therefore, the SFCJPA moved forward with an American Land Title Association (ALTA) and the American Congress on Surveying and Mapping ALTA survey of the Property to determine property boundary, and a Chain-of-Title search.

This undeveloped parcel is approximately 0.47 acres and is intended to remain undeveloped. The SFCJPA has plans to remove invasive species within this parcel and to improve riparian habitat.



Additional information

We met with Mr. Reller last month and informed him of the results of the ALTA survey and chain of title results. Mr. Reller wanted to move forward with the property donation.

The Executive Director or her designee is further authorized and directed, to do any and all things which the Executive Director may deem necessary or advisable to effectuate this Resolution and any such actions previously taken in connection with this conveyance are hereby ratified and confirmed.

Dear Mr. Reller,

This letter agreement (the "Letter") has been sent to you to confirm certain understandings between William E. Reller, as Trustee of the Reller Survivor's Trust (the "Donor") and the San Francisquito Creek Joint Powers Authority (the "Authority") with respect to the proposed donation by the Donor to the City of that certain property described in Exhibit "A" attached hereto (the "Property").

The Donor and the Authority agree that:

<u>Section 1</u>. Prior to the conveyance of the Property to the Authority, the Authority shall engage an appraiser mutually acceptable to the Authority and the Donor to determine the fair market value of the Property. The Authority shall be responsible for the payment of the fees charged by the appraiser. The Authority will provide a copy of the final appraisal report to the Donor. Subject to the following, the donation shall be effected within sixty (60) days following the date of the Donor's execution of this Letter. Subject to a written amendment hereof by the undersigned to the contrary, this Letter shall automatically terminate if the donation is not effected within such sixty (60) day period. The Authority shall not in any manner be responsible for the accuracy of the appraisal. The Authority shall not be responsible for the payment of the fees of any other appraiser with respect to the appraisal described in this Section 1. Notwithstanding anything to the contrary contained herein, the Donor shall have the right to terminate this Letter upon ten (10) days written notice to the Authority if the appraised value of the Property is not acceptable to Donor.

<u>Section 2</u>. The Property shall be conveyed to the Authority pursuant to the Grant Deed in substantially the form attached hereto as Exhibit "B", and/or a quitclaim deed in a form satisfactory to the Donor and the Authority. The Authority shall not, by this Letter, be obligated to accept the donation unless and until it has received a binding commitment by First American Title Insurance Company to issue an owner's title insurance policy satisfactory in form and substance to the Authority.

<u>Section 3</u>. The Donor and the Authority agree that the Authority has not and will not provide any advice or make any representation to Donor with respect to the tax impacts upon the Donor resulting from their donation of the Property to the Authority. In addition, the Donor shall indemnify and hold the Authority harmless from any costs, expenses, or liability that the Authority may incur and that arise directly or indirectly from any tax impacts upon the Donor as a result of the donation. This indemnity shall survive the donation.

Agenda Item 10: Hortscience/Bartlett Contract Amendment

Background

The SFCJPA has a goal to reduce the Upstream project footprint to preserve as many trees as possible based on tree condition. The SFCJPA hired HortScience | Bartlett Consulting in March 2020 to identify and evaluate the condition of trees that may be affected by the Upstream Project using the project footprint from our Environmental Impact Report.

The arborist team evaluated and mapped a total of 535 trees that may possibly be affected by construction of the Upstream Project. The draft Arborist report was submitted to our member cities for review on August 31.

The SFCJPA requested a proposal for an amendment to the contract to respond to member cities comments on the draft report and prioritize and reduce the number of trees that may be affected by the project.

Additional information

The original contract is for \$31,500, and this amendment requests an additional \$10,000.

This amendment will identify trees that will be removed and preserved and provide guidelines for tree preservation during the design, construction and maintenance phases. This information will be compiled specific to each city.

ACTION:

Recommend approving the amendment for \$10,000 to address comments on the draft Arborist Report for the Upstream project.


